

**RESOLUTION R:80-2023**

**RESOLUTION OF THE TOWNSHIP OF MONROE  
AMENDING RESOLUTION R:51-2023 REJECTING ALL BIDS FOR  
WILLIAMSTOWN FIRE STATION DEMOLITION PROJECT**

**WHEREAS**, on January 23, 2023, the Township Council passed Resolution R:51-2023 rejecting all bids for the Williamstown Fire Station Demolition Project; and

**WHEREAS**, the Township Council seeks to amend Resolution R:51-2023, due to a mistake regarding the reason for rejecting all bids by the Township Council; and

**WHEREAS**, the Township of Monroe authorized the receipt of bids for the Williamstown Fire Station Demolition Project; and

**WHEREAS**, on November 29, 2022, seven (7) sealed bids were received and opened; and

**WHEREAS**, said bids were as follows:

1. Brennan Brothers Contracting, LLC - \$109,529.00;
2. Neri's Construction & Rentals, Inc. - \$85,000.00;
3. Tamco Construction, Inc. - \$134,500.00;
4. F.R. Beinke Wrecking, Inc. - \$122,400.00;
5. Ricco Construction Corp. - \$170,000.00;
6. The Ambient Group, LLC - \$178,000.00; and
7. Caravella Demolition - \$119,221.00.

**WHEREAS**, pursuant to N.J.S.A. 40A:11-13.2, a contracting unit is permitted to reject all bids when the governing body decides to abandon the project for provisions for performance of the goods or services; and

**WHEREAS**, it is the desire of Township of Monroe to reject all bids received on November 29, 2022, because at this time, the Township seeks to abandon the Williamstown Fire Station Demolition Project; and

**WHEREAS**, the Township Council of the Township of Monroe hereby determines that it is in the best interest of the Township to reject all bids; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe as follows:

1. The Township Council hereby amends Resolution R:51-2023 as defined herein.
2. It hereby rejects all bids received for the Williamstown Fire Station Demolition Project for the reasons set forth in this Resolution.
