

RESOLUTION R:93-2023

A RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING PARTICIPATION IN A SHARED SERVICES AGREEMENT WITH THE MANTUA FIRE DISTRICT NO. 1 FOR MECHANIC SERVICES

WHEREAS, the Township of Monroe is authorized by the “Shared Services Act”, N.J.S.A. 40A:65-4 et seq. to enter into any contract with joint provision of any service which any party to the agreement is authorized to render within its own jurisdiction; and

WHEREAS, the Township of Monroe recognizes the need to provide residents of the Township with appropriate cost savings measures and opportunities for the benefit of all residents of the Township; and

WHEREAS, the Township of Monroe has identified a need to have vehicle and small engine maintenance, repair, upfitting, and outfitting services performed on vehicles and small engines owned and operated by the Township; and

WHEREAS, the Mantua Fire District No. 1 has the ability to provide these maintenance, repair, upfitting, and outfitting services for the Township’s vehicles in need of repair; and

WHEREAS, the Township of Monroe and the Mantua Fire District No. 1 would maintain the mutual responsibilities as detailed in the attached Shared Services Agreement between the parties for the period of January 1, 2023 through December 31, 2025; and

WHEREAS, the Township of Monroe evidences its desire to enter into such Shared Services Agreement through passage of this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey that:

1. The attached Shared Services Agreement between the Township of Monroe and the Mantua Fire District No. 1 for mechanic services is hereby adopted and shall be effective for the period of January 1, 2023 through December 31, 2025.
2. The Mayor and Township Clerk are hereby authorized to sign, seal, and execute the Shared Services Agreement on behalf of the Township of Monroe.
3. The Township Administrator of the Township of Monroe is authorized to take any action necessary to implement the terms of the Shared Services Agreement.
4. All terms, conditions and responsibilities between the parties as detailed in the attached Shared Services Agreement shall remain in full force and effect.
