**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE,
COUNTY OF GLOUCESTER, TO EXECUTE A GRANT APPLICATION
ON BEHALF OF THE MUNICIPAL ALLIANCE PROGRAM
(Fiscal Grant Cycle July 2020 – June 2025, Grant Year: 24, Tier 1, July 1, 2023 – June 30, 2024)**

WHEREAS, the Governor’s Council on Alcoholism and Drug Abuse established the Municipal Alliances for the prevention of alcoholism and drug abuse in 1989 to educate and engage residents, local government and law enforcement officials, schools, non-profit organizations, the faith community, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in communities throughout New Jersey; and

WHEREAS, the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey recognizes that the abuse of alcohol and drugs is a serious problem in our society amongst persons of all ages and therefore has established a Municipal Alliance Committee; and

WHEREAS, the Township Council of the Township of Monroe further recognizes that it is incumbent upon not only public officials but upon the entire community to take action to prevent such abuses in our community; and

WHEREAS, the Township Council of the Township of Monroe has applied for funding to the Governor’s Council on Alcoholism and Drug Abuse through the County of Gloucester; and

NOW, THEREFORE, BE IT RESOLVED that the Township Council of the Township of Monroe does hereby recognize the following:

1. The Township Council does hereby authorize submission of a strategic plan for the Monroe Municipal Alliance grant for fiscal year 2023 in the amount of:

DEDR	\$ 6,000.00
Cash Match	\$ 1,500.00
In-Kind	\$ 4,500.00
Total Alliance Budget	\$12,000.00

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Township Council of the Township of Monroe acknowledges the terms and conditions for administering the Municipal Alliance Grant, including the administrative compliance and audit requirements.
