**RESOLUTION OF THE TOWNSHIP OF MONROE DESIGNATING A BUS STOP
ALONG CROSSKEYS AVENUE**

WHEREAS, the Township of Monroe supports the expansion of public transportation to and from the Township; and

WHEREAS, to increase travel and the ability of residents and visitors to access the amenities of the Township, the Township Council seeks to expand the amount of bus stops located in the Township; and

WHEREAS, the proposed location is at Crosskeys Avenue and has been an unofficial New Jersey Transit bus stop within the Township; and

WHEREAS, New Jersey Transit has evaluated and approved the location of this bus stop; and

WHEREAS, the Township, in conjunction with New Jersey Transit, seeks to add a sign delineating this space as a designated New Jersey Transit bus stop and official notice this as a bus stop.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Monroe, County of Gloucester, and State of New Jersey that:

Pursuant to N.J.S.A. 39:4-8(e), the following described location is designated as a bus stop:

1. Along Main Street, northbound, on the easterly side thereof at:
 - a. Crosskeys Avenue – far side
Beginning at the southerly curb line of Crosskeys Avenue and extending 300 feet southerly therefrom.
2. The Mayor and/or his designee is authorized to take all steps necessary to effectuate the implementation of the sign and bus stop as referenced herein.
3. A copy of this Resolution shall be provided by the Township Clerk and/or her designee to New Jersey Transit demonstrating the Township's approval of the bus stop and signage.
