**RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING PARTICIPATION
IN AN INDEMNIFICATION AGREEMENT WITH BISMILLA RESTAURANT, LLC
D/B/A MONALISIA FOR USE OF A TOWNSHIP PARKING LOT**

WHEREAS, Bismila Restaurant, LLC d/b/a MonaLisia (“MonaLisia”) operates a restaurant business in the Township of Monroe at 745 Corkery Lane, Williamstown, NJ 08094; and

WHEREAS, due to the busy nature of MonaLisia and the other businesses located at or near 745 Corkery Lane, there are times when the shared parking lot is full and unable to accommodate all patrons, guests, and visitors; and

WHEREAS, the Township has additional parking at the EMS Center located at 700 Corkery Lane, Williamstown, NJ 08094 for overflow parking from MonaLisia; and

WHEREAS, in order to permit MonaLisia to use the additional parking at the EMS Center, MonaLisia and the Township intend to enter into an Indemnification Agreement, attached hereto as “Exhibit A”; and

WHEREAS, the purpose of the Indemnification Agreement is to provide the indemnification and insurance provisions agreed to by MonaLisia in order to have access to the additional parking at the EMS Center; and

WHEREAS, the Township of Monroe evidences its desire to enter into such Indemnification Agreement through passage of this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey that:

1. The attached Indemnification Agreement between the Township of Monroe and Bismilla Restaurant, LLC d/b/a MonaLisia for overflow parking is hereby adopted and shall be effective until December 31, 2033.
2. The Mayor and Township Clerk are hereby authorized to sign, seal, and execute the Indemnification Agreement on behalf of the Township of Monroe.
3. The Township Administrator of the Township of Monroe is authorized to take any action necessary to implement the terms of the Indemnification Agreement.
