**RESOLUTION AUTHORIZING THE TOWNSHIP OF MONROE

**WHEREAS**, the Township Council of the Township of Monroe in the County of Gloucester, State of New Jersey consents to the appointment of **COLLIERS ENGINEERING & DESIGN** as the Township Planner for the Township of Monroe.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Monroe, County of Gloucester and State of New Jersey that:

1. The Mayor is authorized to sign a contract with **J. TIMOTHY KERNAN, P.E., P.P., C.M.E.** of the firm **COLLIERS ENGINEERING & DESIGN**, 500 Scarborough Drive, Suite 108, Egg Harbor Township, NJ 08234, on behalf of the Township of Monroe.
2. The contract period shall be effective until December 31, 2023.
3. The CFO has certified that funds are available in the budget account number 3-01-21-200-200-519, Planning – Professional/Contractual Services.
4. Notice of the contract award shall be published in one of the official newspapers for the Township of Monroe.
