**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE
IN SUPPORT OF THE LOCATION AND OPERATION OF A CLASS 5 CANNABIS
RETAIL FACILITY BY GREEN LEAF WELLNESS SOLUTIONS LLC**

WHEREAS, in November 2020, New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to legalize a controlled form of marijuana called “cannabis” for adults at least 21 years of age; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (the “Act”), which legalizes the recreational use of cannabis by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational cannabis operations, use and possession; and

WHEREAS, section 31a of the Act authorizes municipalities by ordinance to adopt regulations governing the number of cannabis businesses allowed to operate within their boundaries, as well as the location, manner, and times of operation of such businesses, and establishing civil penalties for the violation of any such regulations; and

WHEREAS, by Ordinance introduced June 29, 2021, the Governing Body of the Township of Monroe permitted and established land use regulations and local taxes for regulated cannabis businesses within the Township in accordance with the Act and the New Jersey Municipal Land Use Law; and

WHEREAS, under the Act, prospective cannabis business license-applicants are required to submit to the New Jersey Cannabis Regulatory Commission (“CRC” or “Commission”), inter alia, a Resolution from the governing body of any potential host-municipality, certifying that the municipality has authorized the type of cannabis business license being sought by the license-applicant to operate within its jurisdiction, and a confirmation that, if the municipality has imposed a limit on the number of licensed cannabis businesses, the issuance of a license to the applicant by the Commission would not exceed that limit; and

WHEREAS, the Township recognizes that the ultimate decision to approve any new cannabis licensees is guided by the standards identified within the New Jersey Cannabis Laws and vested to the discretion of the CRC; and

WHEREAS, the Township supports cannabis businesses that might otherwise seek to operate within the Township, subject to reasonable time, place, and manner restrictions imposed by any lawfully adopted ordinance; and

WHEREAS, such a business would create job opportunities for residents of Monroe Township and contribute to the local economy; and

WHEREAS, the Township has received a request for such an aforementioned Resolution from Green Leaf Wellness Solutions LLC which seeks approval from the CRC for a Class 5 Retailer Cannabis Business License to be located within the Township at the address 4 S. Black Horse Pike, Williamstown, NJ 08094, identified by Block 1901, Lot 1, located in the Combined CCMWD and CR & D Zoning Overlay District where retail cannabis is permitted.

BE IT FURTHER RESOLVED, the Township also hereby confirms that the ultimate issuance of a license to Green Leaf Wellness Solutions LLC by the CRC would not exceed any limit on retailers identified by the Ordinance.

BE IT FURTHER RESOLVED, Green Leaf Wellness Solutions LLC understands and acknowledges that this Resolution of Support does not guarantee Green Leaf Wellness Solutions LLC an award of the ability for Green Leaf Wellness Solutions LLC to operate such a business within the Township.

BE IT FURTHER RESOLVED, that a certified copy of this resolution be forwarded to the Township Administrator, Director of Community Development, and Green Leaf Wellness Solutions LLC.

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately upon passage.
