K.) **NEW BUSINESS**

Cncl. Garbowski spoke in reference to the conditions of the Public Works Department, expressing his concerns with the conditions of the building and the amount of traffic that is coming and going without a safe passage way. He asked for the Mayor and Council's support for the Township to obtain an architect engineering firm to look at the future of Public Works. The Township is expanding very rapidly and it will continue to do so, and in order to accommodate the expansion, Public Works will also need to expand.

Cncl. Garbowski spoke regarding the parking along Main Street. He noted, the Township has been donated the parking area located behind Newfield Bank along with all of the ground located behind the existing restaurants and businesses along Main Street that connect to the parking area. He would like the Township to obtain an engineering firm to research what is entailed in potentially rehabbing and expanding the area. Cncl. Garbowski believes, if the area is expanding and rehabbed, it will allow for a lot more traffic to come to Main Street. Business Administrator, Jim DeHart advised, he has recently spoken with Triad, the Township's Grant Writer, noting he has placed the parking area located behind Newfield Bank on a target list to research for any available possible grants to help fund the project.

M.) REPORTS AND OTHER MATTERS

Deputy Mayor Kurz attended along with the Mayor and several other Township officials, the Ribbon Cutting Ceremony at Nicoletto's on Main Italian Restaurant on April 12th. He congratulated the new owners, wishing them the best of luck in their new venture. On April 20th, he attended with the Mayor and several other Township officials, the return of the Honor Flight at Williamstown High School. Mr. Kurz offered the veterans a large thank you.

Director of Code Enforcement, Mr. Sebastian reported, for the month of March, the Construction Department has performed 357 building inspections, 99 fire inspections, 340 electrical inspections, 240 plumbing inspections, and 111 mechanical inspections, for a total of 1,147 inspections. The Housing Department has performed 156 inspections and the Zoning Department had 94 applications reviewed, for a grand total of 1,397 inspections and year to date, through March a grand total of 3,875 inspections.

Director of Community Affairs, Mrs. Park reported, the Easter Egg Hunt, which was scheduled for April 1st, was rescheduled to April 2nd due to the inclement weather, noting there

was a great turnout regardless of the change of date. On April 22nd, Community Affairs held the Annual Autism Awareness Day event, noting this was the first event to be held at the Pfeiffer Community Center since the construction has begun. The Township Senior Bus Trip to Smithville took place on April 13th. Community Affairs has a bus trip to the casinos and a Kenny Rogers impersonator show scheduled for Thursday, April 27th. The Seniors Commission has a bus trip to Tomasello Winery scheduled for May 9th. Tickets are still available and residents may call 856-728-9841 for further information.

Director of Public Safety, Mr. Rumpf reported that the Police Department handled 5,087 calls for service for the month of March, with a grand total of 15,420 calls year to date. Williamstown Fire Department reported 48 calls for service in March along with 4 attended training drills. Cecil Fire Department reported 23 calls for service in March. There is no report for the Monroe EMS at this time.

Police Chief Monahan attended the Honor Flight at Williamstown High School on April 20th, noting that it is an honor for him and the Police Department to be a part of the Honor Flight and to show their appreciation to the veterans. He said, the Police Department escorts the veterans all the way to the Delaware Memorial Bridge. Chief Monahan thanked his officers for their dedication and service to this fantastic event, which takes place twice a year.

Cncl. Adams attended the Municipal Alliance meeting this month, where they are working on an art contest with the middle school to help raise awareness of the dangers of drug abuse and usage. The Commission is also preparing for National Night Out, which will be held on August 1st. The Commission has plans to work alongside the Seniors Commission, as they were presented with the numbers of overdoses in the town, where it showed that 1/3 of the overdoses were due to unintentional medication overdose by seniors. Cncl. Adams noted, she had the honor of attending the Honor Flight. She thanked everyone involved in the event. Cncl. Adams commended all of the Directors for all of their hard work, noting it was a busy weekend around town, with the autism awareness event at the Pfeiffer Community Center, the annual shredding event at Public Works, and Opening Day at the Little League Fields.

Cncl. Garbowski attended the Library Board meeting on April 19th, where they announced that the Friends of the Library raised \$1,588 from their book sale. He thanked everyone for participating with the event. Cncl. Garbowski invited everyone to visit the "Out and About" section at the Library, which provides information on the various events taking place in and around Monroe Township.

Cncl. Vice-Pres. Valcourt stated that the Open Space Advisory Committee is interested in receiving wildflower donations and wanted to know if it is appropriate to accept the donations. Solicitor Cappelli advised, he will look into this matter and inform Cncl. Vice-Pres. Valcourt his findings.

Cncl. Pres. Fox attended the Ribbon Cutting Ceremony at Nicoletta's on Main. She congratulated the owners and wished them the best of luck. Cncl. Pres. Fox attended the Honor Flight and it was an honor to see the veterans. She invited everyone to attend the Honor Flight event in the future, noting it is a very emotional experience. She thanked Director of Community Affairs, Donna Park for the update pertaining to the Seniors Commission's upcoming trip. Cncl. Pres. Fox invited all of the residents to visit the Seniors Commission section of the Township's website to see all of the events that are scheduled and will be scheduled shortly.

Municipal Clerk, Aileen Chiselko thanked Council and the Mayor, on behalf of herself and Deputy Municipal Clerk, Jenn Harbison, for the proclamation. She expressed her appreciation for the recognition and noted that she could not perform her job without the assistance of her team, Jenn Harbison, Lisa Christman and Gabby Bates, of the Clerk's Office.
