**RESOLUTION OF THE TOWNSHIP OF MONROE, COUNTY OF GLOUCESTER,
STATE OF NEW JERSEY, REGARDING THE RATIFICATION OF PAYMENT TO
CAPTAIN ERIK LEWIS, FORMERLY OF THE MONROE TOWNSHIP
POLICE DEPARTMENT**

WHEREAS, this Township recognizes that Captain Erik Lewis (Capt. Lewis), formerly of the Monroe Township Police Department, has retired on April 1, 2022; and

WHEREAS, Capt. Lewis received Tier 4 medical benefits while paying for Tier 3 medical benefits; and

WHEREAS, Capt. Lewis has paid the price difference in benefits to the Township; and

WHEREAS, Capt. Lewis was not paid in accordance with the applicable Collective Bargaining Agreement for Captain's pay during his service; and

WHEREAS, the Township has determined that it is in the best interest of the Township and its taxpayers to reimburse Capt. Lewis the money owed to him; and

WHEREAS, the Township wishes to pay Capt. Lewis the proper amount for his time serving as Captain under the applicable Collective Bargaining Agreement; and

WHEREAS, Capt. Lewis should have been paid an additional \$1,719.60 for his service as Captain; and

WHEREAS, the Township and Capt. Lewis have agreed to the payment amount of \$1,719.60; and

WHEREAS, such payment will resolve all compensation issues pertaining to Capt. Lewis' employment; and

WHEREAS, such payment must be released by the Township's financial officer.

NOW, THEREFORE, BE IT RESOLVED that the Township of Monroe hereby ratifies the allocation of \$1,719.60 to Capt. Lewis, to be released at the earliest possible date; and

NOW, IT BE FURTHER RESOLVED that the Township and its Council authorizes the execution of a Waiver of Claims Agreement with Capt. Lewis, which will release the Township from any and all claims or causes of action related to these payments.
