**RESOLUTION AUTHORIZING THE TOWNSHIP OF MONROE
TO ENTER INTO A CONTRACT WITH THE MUNICIPAL BOND COUNSEL

WHEREAS, there exists the need for services of a Municipal Bond Counsel in the Township of Monroe, County of Gloucester, State of New Jersey; and

WHEREAS, the Local Public Contracts Law N.J.S.A. 40:11-1 et seq. requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bids must be advertised; and

WHEREAS, this contract is awarded in accordance with the Fair and Open procedures as established in the "Pay to Play" Law N.J.S.A. 19:44A-20.5 et seq.; and

WHEREAS, the Township Council of the Township of Monroe in the County of Gloucester, State of New Jersey consents to the appointment of **PARKER McCAY, P.A.** as the Municipal Bond Counsel for the Township of Monroe.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Monroe, County of Gloucester and State of New Jersey that:

1. The Mayor is authorized to sign a contract with **PARKER McCAY, P.A.**, 9000 Midlantic Drive, Suite 300, Mount Laurel, NJ 08054, on behalf of the Township of Monroe.
2. This contract period shall be effective until to December 31, 2023.
3. The CFO has certified that funds are available in the budget account number 3-01-20-130-130-519, entitled Finance – Professional/Contractual Services.
4. Notice of the contract award shall be published in one of the official newspapers for the Township of Monroe.
