

**RESOLUTION R:133-2023**

**A RESOLUTION OF THE TOWNSHIP OF MONROE APPROVING A JURISDICTIONAL AGREEMENT WITH THE NEW JERSEY DEPARTMENT OF TRANSPORTATION ADDRESSING LEGAL AND MAINTENANCE RELATED-ISSUES FOR PROSSER AVENUE AND VERONICA LANE**

**WHEREAS**, the New Jersey Department of Transportation is making improvements to State Highway Route 42; and

**WHEREAS**, Prosser Avenue and Veronica Lane are affected by the improvements; and

**WHEREAS**, Prosser Avenue and Veronica Lane are the responsibility of the Township; and

**WHEREAS**, in order to prevent future legal or maintenance issues in these areas, it is necessary that the Parties apportion the jurisdiction for highway maintenance and control in an equitable manner pursuant to N.J.S.A. 27:7-1 to -44.22; and

**WHEREAS**, it is in the best interest of the Township and its residents that an agreement be entered into for the purpose of governing the responsibilities of the Township and the New Jersey Department of Transportation as it relates to Township and State roads.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey that the Mayor is authorized to execute Jurisdictional Agreement #4885 by and between the Township of Monroe and the New Jersey Department of Transportation which shall govern future legal and maintenance related issues as it relates to State Highway Route 42 from Veronica Lane, Monroe Township to Hurff Lane, Washington Township.
