

RESOLUTION R:135-2023

**RESOLUTION OF THE TOWNSHIP OF MONROE DESIGNATING A BUS STOP
ALONG CROSSKEYS AVENUE**

WHEREAS, the Township of Monroe supports the expansion of public transportation to and from the Township; and

WHEREAS, to increase travel and the ability of residents and visitors to access the amenities of the Township, the Township Council seeks to expand the amount of bus stops located in the Township; and

WHEREAS, pursuant to N.J.S.A. 39:4-8(e), the following locations are hereby designated as a bus stop:

1. Along North Main Street, northbound, on the easterly side thereof at:
 - a. **Between Cross Keys Avenue and Comfort Road** - (mid-block)
Beginning 300 feet south of the prolongation of the southerly curb line of Cross Keys Avenue and extending 135 feet southerly therefrom.
2. Along North Main Street, southbound, on the westerly side thereof at:
 - a. **Between Cross Keys Avenue and Comfort Road** - (mid-bloc)
Beginning 300 feet south of the southerly curb line of Cross Keys Avenue and extending 135 feet southerly therefrom.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Monroe, County of Gloucester, and State of New Jersey that:

1. The Mayor and/or his designee is authorized to take all steps necessary to effectuate the implementation of the signs and bus stops as referenced herein.
2. A copy of this Resolution shall be provided by the Township Clerk and/or her designee to New Jersey Transit demonstrating the Township's approval of the bus stop and signage.
