RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING THE MAYOR TO EXECUTE A SETTLEMENT AGREEMENT AND MUTUAL RELEASE BETWEEN THE TOWNSHIP OF MONROE, NISSAN MOTOR ACCEPTANCE CORPORATION, AND STEVE'S AUTOBODY & REPAIR, LLC

WHEREAS, the Township of Monroe seeks to enter into a settlement agreement and mutual release with Nissan Motor Acceptance Corporation and Steve's Autobody & Repair, LLC; and

WHEREAS, Nissan Motor Acceptance Corporation filed a lawsuit in 2021 asserting an interest in a motor vehicle, which was taken into possession and disposed of by Monroe Township and/or Steve's Autobody & Repair, LLC; and

WHEREAS, the Township of Monroe and/or Steve's Autobody & Repair, LLC are no longer in possession of said vehicle; and

WHEREAS, the Parties have agreed to enter into this settlement agreement and mutual release in order to avoid uncertainty, expenses and delay inherent litigation, and to enter into final settlement and discharge of any and all claims pertaining to said lawsuit; and

WHEREAS, after due deliberation and consultation, the Township Council of the Township of Monroe has determined it is in the best interest of the residents of the Township of Monroe that said settlement agreement and mutual release be authorized.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey that the settlement agreement and mutual release by and between the Township of Monroe, Nissan Motor Acceptance Corporation, and Steve's Autobody & Repair, LLC be authorized.
