

**RESOLUTION R:153-2023**

**RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING THE INCREASE  
IN SALARY COMPENSATION OF THE CHIEF OF POLICE**

**WHEREAS**, the Township of Monroe desires to amend the compensation of the Chief of Police to reflect new salary increases; and

**WHEREAS**, these changes are in accordance with the New Jersey Statutes Annotated N.J.S.A. 40A:14-179 which governs the compensation for such roles within the Township; and

**WHEREAS**, the proposed salary increase is fair and in line with the responsibilities and duties of the Chief of Police; and

**WHEREAS**, after due deliberation and consultation, the Township Council of the Township of Monroe has determined it is in the best interest to increase the compensation of the Chief of Police in order to comply with N.J.S.A. 40A:14-179.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey that:

1. Effective January 1, 2022, the salary of the Chief of Police shall be increased to \$168,667.00.
2. Effective July 1, 2022, the Chief of Police shall receive an additional increase of 4.5%, taking his salary to \$176,257.00.
3. All other terms and conditions of the employment contract between the Township and the Chief of Police shall remain unchanged and in full force and effect.
4. The Chief of Police will be paid retroactive pay, commencing from the effective dates of the respective salary changes, in accordance with the new salary structure as outlined herein.

**ADOPTED** at a meeting of the Township Council of the Township of Monroe on June 26, 2023.
