**RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING THE MAYOR TO EXECUTE A SIDE LETTER AGREEMENT BETWEEN THE TOWNSHIP OF MONROE AND UNITED FOOD & COMMERCIAL WORKERS UNION LOCAL 360**

**WHEREAS**, the Township of Monroe seeks to enter into a collective bargaining agreement with United Food & Commercial Workers Union, Local 360; and

**WHEREAS**, the United Food & Commercial Workers Union, Local 360 currently provides the Township and its residents with services for the Department of Public Works; and

**WHEREAS**, the Township of Monroe, the Township Council, and the Mayor agree that the United Food & Commercial Workers Union, Local 360 collective bargaining agreement should be in full force and effect; and

**WHEREAS**, in furtherance of same, the parties have negotiated a written collective bargaining agreement extension between the Township of Monroe and United Food & Commercial Workers Union, Local 360; and

**WHEREAS**, the collective bargaining agreement between the parties failed to address the position and salary for a Senior EMT Technician for the rate of \$33.30 per hour; and

**WHEREAS**, upon due diligence and deliberation, the Township Council and the Mayor find it in the best interest of Township residents to enter into this side letter agreement in order to allocate for a Senior EMT Technician for the rate of \$33.30 per hour, effective July 31, 2023.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey that the side letter agreement allowing for a Senior EMT Technician be authorized, effective July 31, 2023.

**ADOPTED** at a meeting of the Township Council of the Township of Monroe on June 26, 2023.
