RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING THE PARTICIPATION IN A SHARED SERVICES AGREEMENT WITH THE MONROE TOWNSHIP MUNICIPAL UTILITIES AUTHORITY

WHEREAS, the Township of Monroe is authorized by the “Shared Services Act,” N.J.S.A. 40A:65-4 et seq. to enter into any contract with joint provision of any service which any party to the agreement is authorized to render within its own jurisdiction; and

WHEREAS, the Township of Monroe recognizes the need to provide residents of the Township with appropriate cost savings measures and opportunities for the benefit of all residents of the Township; and

WHEREAS, each entity seeks to lower costs of services to their respective residents and each desire to seek ways to share and/or consolidate municipal services where possible; and

WHEREAS, in attempt to identify cost savings measures the Township has discussed the ability to share service with the Monroe Township Municipal Utilities Authority (“MMUA”); and

WHEREAS, the Parties are interested in entering into this Shared Services Agreement in which the MMUA agrees to provide printing and/or mailing services of periodic newsletters for Township notifications to be sent out with alongside the MMUA’s water/sewer bills, and the Township agrees to provide periodic police traffic assistance on busy State and/or county roadways when needed by the MMUA; and

WHEREAS, MMUA and the Township have negotiated this “Shared Services Agreement” between the Township of Monroe and the Monroe Municipal Utilities Authority; and

WHEREAS, the Township Council and the Mayor seek to enter into this Shared Services Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey that:

1. The Township Council seeks to enter into the Shared Services Agreement with the Monroe Township Municipal Utilities Authority for the MMUA to provide printing and/or mailing services of periodic newsletters with Township notifications in exchange for periodic police traffic assistance effective immediately.
