WHEREAS, Remington & Vernick Engineers, Township Engineer on the Project, by revised letter dated May 16, 2023, required a Performance Guarantee (Landscape Buffer) amount and inspection escrow for the Site known as Blaze Mill Development – Phase I (Block 14101, Lot 1 and Block 141.0602, Lot 1.01); and

WHEREAS, Remington & Vernick Engineers estimated the improvement requires a guarantee of a Performance Guarantee (Landscape Buffer) for the Project as follows:
