# AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE AUTHORIZING THE PURCHASE OF BLOCK 6001, LOT 19 FROM THE GLOUCESTER COUNTY 4H ASSOCIATION

WHEREAS, the Township of Monroe, County of Gloucester, State of New Jersey ("Township") previously acquired title to Block 6001, Lot 19 ("Property") pursuant to a tax sale foreclosure proceeding In Rem by Final Judgment (In Rem) in the Superior Court of New Jersey, Chancery Division, dated January 3, 1996 and recorded May 5, 1997 in Deed Book 2760, Page 77; and

WHEREAS, on March 29, 2010, a deed was entered conveying the Property from the Township to the Gloucester County 4H Association and/ or under the umbrella organization, Rutgers Cooperative Research & Extension ("Association") for \$1.00, for the Property to be used for recreational purposes; and

**WHEREAS**, the Association can no longer maintain the Property and desires to return it to the Township; and

WHEREAS, the Township and its Council believes it for the best interest of its citizens and residents to purchase the Property back for \$1.00, and has determined it to be in the best interest of the public to acquire the Property for public use; and

**WHEREAS,** N.J.S.A. 40A:12-5 provides authority for municipalities to acquire real property for public use, by purchase or otherwise.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Monroe that the Code of the Township of Monroe as follows:

**SECTION I.** Pursuant to N.J.S.A. 40A:12-5, the Township is hereby authorized to enter into an agreement with the Gloucester County 4-H Association for the purchase of the Property for the sum of One Dollar (\$1.00) and other valuable consideration, if any.

**SECTION II.** The Mayor, Township Clerk, and other appropriate officials of the Township are hereby authorized and directed to execute any and all documents necessary to effectuate the purchase of the Property.

**SECTION III.** If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.

**SECTION IV.** All prior Ordinances or parts of ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
