

RESOLUTION R:178-2023

RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A SHARED SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF MONROE AND THE COUNTY OF GLOUCESTER, NEW JERSEY FOR USE OF THE FUEL SYSTEM

WHEREAS, the Township of Monroe (“Township”) owns and operates fuel facilities for the provisions of “regular” gasoline and diesel gasoline (collectively “fuel”); and

WHEREAS, the County of Gloucester, New Jersey (“Gloucester County”) is desirous of purchasing fuel from the Township, for its use, specifically for their EMS vehicles, as per the terms of the attached Agreement; and

WHEREAS, this Agreement is established in accordance with the “Uniform Shared Services and Consolidation Act,” N.J.S.A. 40A:65-1 et seq., as the Governing Body of the Township and Gloucester County have determined that the Agreement will benefit the general welfare of its citizens; and

WHEREAS, the Township and Gloucester County have determined that it is the most cost effective and advantageous for the Township, Gloucester County, and the residents thereof for the Township and Gloucester County to share fuel services.

NOW, THEREFORE, BE IT RESOLVED that the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey, does hereby authorize the Mayor to execute an Agreement with the County of Gloucester, New Jersey to participate in an Agreement for the fuel system, said agreement attached hereto.
