**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE

WHEREAS, Remington & Vernick Engineers, Township Engineer on the Project, by revised letter dated March 28, 2023 (*revised May 16, 2023*), required a Performance Guarantee amount and inspection escrow for the Site known as Blaze Mill Development – Phase IV (Block 14101, Lot 1 and Block 141.0602, Lot 1.01); and

WHEREAS, Remington & Vernick Engineers estimated the improvement requires a guarantee of a Performance Guarantee for the Project as follows:
