**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE

IN THE AMOUNT OF \$30,480.00 FOR BLAZE MILL DEVELOPMENT,

(LANDSCAPE BUFFER)**

WHEREAS, Remington & Vernick Engineers, Township Engineer on the Project, by revised letter dated March 28, 2023 (*revised May 16, 2023*), required a Performance Guarantee (Landscape Buffer) amount and inspection escrow for the Site known as Blaze Mill Development – Phase IV (Block 14101, Lot 1 and Block 141.0602, Lot 1.01); and

WHEREAS, Remington & Vernick Engineers estimated the improvement requires a guarantee of a Performance Guarantee (Landscape Buffer) for the Project as follows:

WHEREAS, Blaze Mill Development Group, LLC, Developer, issued a Performance Surety Bond For Landscape Buffer Performance Guarantee in the amount of \$30,480.00 for the Project; and

WHEREAS, the Township of Monroe accepts the form of said Performance Guarantee.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester and State of New Jersey on this 24th day of July, 2023, that:
