**WHEREAS**, Remington & Vernick Engineers, Township Engineer on the Project, by letter dated February 28, 2023, required a Performance Guarantee (Landscape Buffer) amount and inspection escrow for the Site known as The Greens – Phase 2 (Block 14801, Lot 12); and

**WHEREAS**, Remington & Vernick Engineers estimated the improvement requires a guarantee of a Performance Guarantee (Landscape Buffer) for the Project as follows:

Landscape Buffer Maintenance Guarantee	\$5,211.00
Stormwater Management Maintenance Guarantee	\$930.00
Engineering Inspection Escrow*	\$37,046.67

**WHEREAS**, Hovbros Greens, LLC, Developer, issued a Landscape Buffer Performance Guarantee in the amount of \$34,740.00 for the Project; and
