**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE
AUTHORIZING THE ACCEPTANCE OF A PERFORMANCE GUARANTEE
IN THE AMOUNT OF \$302,994.00 FOR MALAGA ROAD TRACT
(A/K/A MALAGA MEADOWS), SECTION 4, SUBDIVISION #1828
(BLOCK 2702, LOTS 11, 15, 17, 40 AND 41)**

WHEREAS, Remington & Vernick Engineers, Township Engineer on the Project, by letter dated June 29, 2023, required a Performance Guarantee amount and inspection escrow for the Site known as Malaga Road Tract (a/k/a Malaga Meadows) – Section 4 (Block 2702, Lots 11, 15, 17, 40 and 41); and

WHEREAS, Remington & Vernick Engineers estimated the improvement requires a guarantee of a Performance Guarantee for the Project as follows:
