## AN ORDINANCE OF THE TOWNSHIP COUNCIL OF MONROE GRANTING AN ACCESS EASEMENT TO KELLIE A. AYERS AND AUTHORIZING EXECUTION OF ACCESS EASEMENT AGREEMENT

**WHEREAS**, the Township of Monroe ("Township") is the owner of certain lands located in the Township designated as Block 11203, Lot 27 on the Township Tax Map (the "Property"); and

**WHEREAS,** Kellie A. Ayers is the owner of certain lands located in the Township designated as Block 11203, Lot 26.01 on the Township Tax Map (the "Premises"); and

**WHEREAS,** Kellie A. Ayers has requested that the Township execute an Access Easement Agreement to grant an easement across the Property from Hemlock Drive to the Premises for the purposes of ingress and egress; and

**WHEREAS**, the Township is authorized pursuant to the Local Lands and Building Law, N.J.S.A. 40A:12-1 et seq., to grant interests in real property, including easements, by ordinance; and

**WHEREAS**, the Township Council finds it to be in the best interest of the Township and its citizenry to grant the easement and desires to enter into the Agreement for the aforementioned purposes, subject to the terms and conditions set forth in the Agreement; and

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Township of Monroe, County of Gloucester, State of New Jersey, as follows:

- 1. The Township hereby grants an access easement over Block 11203, Lot 27 to Kellie A. Ayer for the purpose of ingress and egress to and from Block 11203, Lot 26.01, subject to the terms and conditions of the Access Easement Agreement attached hereto.
- 2. The Mayor and the Clerk are hereby authorized and directed to execute the Agreement.
- 3. A copy of the Access Easement Agreement shall be placed on file with the Township Clerk.

**BE IT FURTHER ORDAINED** that ordinances, resolutions, regulations or parts of ordinances, resolutions, and regulations inconsistent herewith are hereby repealed to the extent of such inconsistencies.

**BE IT FURTHER ORDAINED** that this Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
