#### SCHEDULE "A"

##### Refunds

\$1,973.11 to be refunded to Block 29.0101 Lot 3, Corelogic for tax overpayment.

\$34.37 to be refunded to Block 14901 Lot 11 Q-Farm, Lathrop, Charles & Linda for tax overpayment.

\$1,368.22 to be refunded to Block 10603 Lot 12, Bedrock Land Transfer Services LLC for tax overpayment.

##### Cancellations

Marla Hunter-Webster, owner of the property located at, Block 13710, Lot 31, 67 Glasgow Road is a 100% totally disabled veteran and the County Tax Assessor has approved the property tax exemption effective August 7, 2023. Taxes for the tax year 2023 will be canceled in the amount of \$3,205.18, and a refund to Corelogic will be processed in the amount of \$1,187.87.

Nicholas F Furloni, owner of the property located at, Block 13001.01, Lot 10, 150 Presley Way is a 100% totally disabled veteran and the County Tax Assessor has approved the property tax exemption effective March 28, 2023. Taxes for the tax year 2023 will be canceled in the amount of \$1,976.44.

Tracy B Stone, owner of the property located at, Block 13001.02, Lot 28, 113 Presley Way is a 100% totally disabled veteran and the County Tax Assessor has approved the property tax exemption effective May 9, 2023. Taxes for the tax year 2023 will be canceled in the amount of \$1,623.38, and a refund to Corelogic will be processed in the amount of \$1,259.53.

Paul V McCullough III owner of the property located at, Block 36.0101, Lot 9, 1419 Cranleigh Lane is a 100% totally disabled veteran and the County Tax Assessor has approved the property tax exemption effective July 22, 2023. Taxes for the tax year 2023 will be canceled in the amount of \$5,511.58.

Joseph F Kuhn, III, owner of the property located at, Block 3202, Lot 13, 350 Clinton Avenue is a 100% totally disabled veteran and the County Tax Assessor has approved the property tax exemption effective July 10, 2023. Taxes for the tax year 2023 will be canceled in the amount of \$3,532.79, and a refund to Corelogic will be processed in the amount of \$1,673.43.

Block 4301, Lot 26 located on Winslow Road will have taxes in the amount of \$1,068.69 canceled for 2023 tax year as property is now owned by Monroe Township.
