**AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE
REPEALING ORDINANCE O:22-2023**

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Monroe as follows:

SECTION I. Ordinance No. 22-2023 is hereby repealed in its entirety.

SECTION II. This Ordinance shall take effect twenty (20) days after the final passage and publications as required by law.
