# AN ORDINANCE OF THE TOWNSHIP OF MONROE, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY AMENDING CHAPTER 267 OF THE TOWNSHIP CODE ENTITLED "VEHICLES AND TRAFFIC"

**WHEREAS**, the Township Council of the Township of Monroe having considered certain changes to Chapter 267 of the Code of the Township of Monroe in order to meet the needs of all of the residents of the Township of Monroe.

**NOW THEREFORE BE IT ORDAINED** by the Township Council of the Township of Monroe, County of Gloucester, and State of New Jersey as follows:

**SECTION I.** Section 267-27 of the Township Code entitled "Parking of certain vehicles prohibited" is hereby amended as follows:

§ 267-27 Parking of certain vehicles prohibited.

No person shall park any truck, tractor or tractor trailer in excess of 10,000 pounds, nor shall any person park any bus, motor home, camper-type vehicle or camper trailer, boat, boat trailer or any trailer of any kind on any street, road or highway in the Township at any time, except for the pickup or delivery of materials on such streets. All trailer-type vehicles must remain attached to a registered motor vehicle while parked on such streets. Roadway notification trailers may be parked on such streets at the discretion of the Township. All state, county and municipal vehicles, including, but not limited to, fire, ambulance and rescue vehicles, are exempt from the provisions of this section. The provisions of this chapter and section shall not be applicable to any speed-measuring device mounted upon a trailer and parked upon any roadway utilized by the Police Department for enforcement purposes. Further, any locations and/or vehicles outlined in Chapter 267-58.2 of this Code are also exempt from the provisions of this section. For the purpose of this chapter and section, overnight parking shall be defined as between the hours of 10:00 p.m. and 8:00 a.m.

**SECTION II.** Chapter 267-58.2 of the Township Code entitled "Schedule XXVII: Handicapped Parking" is hereby amended as follows:

§ 267-58.2 Schedule XXVII: Handicapped Parking.

In accordance with the provisions of § 267-33.2, the following described locations are designated for handicapped parking only:

Name of Street	Side	Location
South Main Street	East	From the intersecting line of County Route 536 (Poplar Street) south 150 feet then extending for 30 feet south
South Main Street	West	Located 110 feet north of the northern curb line of Chestnut Street and extending to 128 feet.

The following locations are hereby designated as restricted parking spaces for use by persons who have been issued special vehicle identification by the New Jersey Division of Motor Vehicles. Only individuals and/or vehicles which meet the following criteria may park in the designated parking spaces. No other persons shall be permitted to park in these places.

**SECTION III.** All prior Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION IV.** If any word, phrase, clause, section or provision in this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional, such word phrase, clause, section or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

**SECTION V.** This Ordinance shall take effect twenty (20) days after final passage and publication as required by law.
