RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING THE MAYOR TO EXECUTE A SIDE LETTER AGREEMENT BETWEEN THE TOWNSHIP OF MONROE AND MONROE TOWNSHIP SUPERVISOR'S ASSOCIATION

WHEREAS, the Township of Monroe seeks to enter into a collective bargaining agreement with Monroe Township Supervisor's Association; and

WHEREAS, the Monroe Township Supervisor's Association currently provides the Township and its residents with services for the Department of Public Works, Parks and Recreation and municipal office staff; and

WHEREAS, the Township of Monroe, the Township Council, and the Mayor agree that the Monroe Township Supervisor's Association collective bargaining agreement should be in full force and effect; and

WHEREAS, in furtherance of same, the parties have negotiated a written collective bargaining agreement extension between the Township of Monroe and Monroe Township Supervisor's Association; and

WHEREAS, a new "Summer Schedule" was voted on by the Supervisor's Association to mirror the summer schedule of the UFCW 360 as explained in their Collective Bargaining Agreement; and

WHEREAS, after conducting a summer schedule of four (4) ten (10) hour days, it was requested to conduct a trial schedule to determine the feasibility of this schedule as a permanent option; and

WHEREAS, after conducting research, several other local municipalities have converted to a similar 4-day (four day) schedule, year-round; and

WHEREAS, some research show there is a financial benefit to the tax payers due to utility and fuel savings; and

WHEREAS, upon due diligence and deliberation, the Township Council and the Mayor find it in the best interest of Township residents to enter into this side letter agreement to approve the "Summer Schedule" in the Supervisor's Association CBA; and

WHEREAS, in order to allow for this trial schedule to research and determine if this will be beneficial to the tax payers, the municipality and the employees on a permanent basis,

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey that the side letter agreement allowing for a Trial Schedule, effective September 5, 2023 to December 31, 2023.

ADOPTED at a meeting of the Township Council of the Township of Monroe on September 11, 2023.
