RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING THE MAYOR TO EXECUTE A SIDE LETTER AGREEMENT BETWEEN THE TOWNSHIP OF MONROE AND UNITED FOOD & COMMERCIAL WORKERS UNION LOCAL 360

WHEREAS, the Township of Monroe seeks to enter into a collective bargaining agreement with United Food & Commercial Workers Union, Local 360; and

WHEREAS, the United Food & Commercial Workers Union, Local 360 currently provides the Township and its residents with services for the Department of Public Works; and

WHEREAS, the Township of Monroe, the Township Council, and the Mayor agree that the United Food & Commercial Workers Union, Local 360 collective bargaining agreement should be in full force and effect; and

WHEREAS, in furtherance of same, the parties have negotiated a written collective bargaining agreement extension between the Township of Monroe and United Food & Commercial Workers Union, Local 360; and

WHEREAS, after conducting a summer schedule of four (4) ten (10) hour days, it was requested to conduct a trial schedule to determine the feasibility of this schedule as a permanent option; and

WHEREAS, after conducting some research, several other local municipalities have converted to a similar 4-day (four day) schedule, year-round; and

WHEREAS, some research show there is a financial benefit to the tax payers due to utility and fuel savings; and

WHEREAS, upon due diligence and deliberation, the Township Council and the Mayor find it in the best interest of Township residents to enter into this side letter agreement in order to allow for this trial to research and determine if this will be beneficial to the tax payers and the municipality on a permanent basis,

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey that the side letter agreement allowing for a Trial Schedule, effective September 5, 2023 to December 31, 2023.

ADOPTED at a meeting of the Township Council of the Township of Monroe on September 11, 2023.
