**WHEREAS**, the Township of Monroe is in need of a large stage for the Arts and Crafts Fall Festival to be held on September 16, 2023 (rain date September 23, 2023) within the Township of Monroe; and

**WHEREAS**, the Gloucester County Improvement Authority owns and maintains stage units; and

**WHEREAS**, in furtherance of same, the Township of Monroe and Gloucester County Improvement Authority shall enter into a Shared Services Agreement; and

**WHEREAS**, it is necessary for the Mayor to execute said Agreement.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe, County of Gloucester and State of New Jersey, as follows:

1. The Mayor is hereby authorized and directed to execute the attached Shared Services Agreement for the utilization of the large stage owned and maintained by the Gloucester County Improvement Authority at the Township Monroe Arts and Crafts Fall Festival. This Agreement shall be effective from September 15, 2023 through December 31, 2023.
