**RESOLUTION OF THE TOWNSHIP OF MONROE, COUNTY OF GLOUCESTER,
STATE OF NEW JERSEY, AWARDING TOWING LICENSES
FOR THE 2023-2025 TERM**

WHEREAS, Ordinance O:07-2021 an Ordinance of the Township Council of the Township of Monroe Amended Chapter 262 of the Code of the Township of Monroe entitled “Towing”; and

WHEREAS, applications with all required responsive materials were due from the applicants no later than July 15, 2023 (the “Application Deadline”); and

WHEREAS, on or before July 15, 2023, two (2) towing companies identified herein below submitted applications for towing licenses to operate in the Township of Monroe, County of Gloucester and State of New Jersey:

1. A-Jack’s Towing & Recovery
2. Steve’s Autobody & Repair; and

WHEREAS, pursuant to Township Code Section 262-6C, the Director of Law reviewed said applications for completeness and forwarded A-Jack’s Towing & Recovery’s application to the Chief of Police for review pursuant to Township Code Section 262-6D, as all other applications were still deemed insufficient, and without cure of said deficiencies; and

WHEREAS, pursuant to Township Code Section 262-6D, the Chief of Police or the Chief’s designee caused inspections to be conducted of personnel, vehicles, equipment and storage areas at A-Jack’s Towing & Recovery’s tow facilities to determine if the applicant is in compliance with the licensing and eligibility standards set forth in Chapter 262 including all applicable, law, regulatory and performance standards; and

WHEREAS, pursuant to the Township Code Section 262-7, the Chief of Police issued a written report and deemed A-Jack’s Towing & Recovery in compliance with the licensing and eligibility standards set forth in Chapter 262; and

WHEREAS, pursuant to Township Code Section 262-7B, upon consideration of the report issued by the Chief of Police, the Township Council shall award a towing license to the following qualified applicant:

1. A-Jack’s Towing & Recovery.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Monroe, County of Gloucester and State of New Jersey, that a towing license be issued to A-Jack’s Towing & Recovery for a term commencing on October 1, 2023 through September 30, 2025, pursuant to and consistent with Chapter 262 of the Code of the Township of Monroe entitled “Towing”.

BE IT FURTHER RESOLVED that a copy of this Resolution shall be forwarded to the Township of Monroe Police Chief.
