RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING THE MAYOR TO ENTER INTO A TRI-PARTITE TRAFFIC SIGNAL AGREEMENT WITH THE GLOUCESTER COUNTY PLANNING BOARD AND MONROE DEVELOPMENT ASSOCIATES, LLC, FOR THE INSTALLATION OF A NEW TRAFFIC LIGHT AT SICKLerville ROAD (COUNTY ROAD 536 SPUR)

WHEREAS, the Mayor and Council of Monroe Township of Gloucester County, New Jersey (“the Township”) recognizes the increasing need for effective traffic management on Sicklerville Road (County Road 536 Spur); and

WHEREAS, the Township of Monroe recognizes the need to install a new traffic signal in order to safely expediate the movement of traffic; and

WHEREAS, the Gloucester County Planning Board and the Monroe Development Associates, LLC have expressed their willingness to participate in said installation and logistics of said traffic signal; and

WHEREAS, the parties involved, namely the Township, the Gloucester County Planning Board, and Monroe Development Associates, LLC, have expressed a mutual interest in entering into a Tri-Partite Agreement for this purpose; and

WHEREAS, the Township Council and the Mayor seek to enter into this Tri-Partite Agreement; and

NOW THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey that:

1. The Mayor is hereby authorized to execute and enter into a Tri-Partite Traffic Signal Agreement (“the Agreement”) with the Gloucester County Planning Board and Monroe Development Associates, LLC, the contents of which shall be consistent with the terms discussed herein.
2. The Agreement shall specify the roles, responsibilities, financial contributions, and other obligations of each party as it pertains to the installation of a new traffic signal at Sicklerville Road (County Road 536 Spur).
3. All actions taken pursuant to the Agreement shall be in compliance with all federal, state, and local laws, ordinances, and regulations, including but not limited to, public bidding laws and environmental regulations.
4. Upon execution of the Agreement, the Mayor shall take all actions and execute all additional documents necessary to effectuate the purpose of this resolution and the Agreement.
