**WHEREAS**, the provisions of *N.J.S.A. 52:27D-203b* requires that the appointment of a Fire Official shall be made by Resolution of the governing body; and

**NOW, THEREFORE, BE IT RESOLVED**, that in accordance with the provisions of *N.J.S.A. 52:27-203b* and *N.J.A.C. 5:71-2.1 et seq.*, Patrick Mason is appointed as the Fire Official for the Township of Monroe, County of Gloucester, State of New Jersey, effective October 9, 2023.

**BE IT FURTHER RESOLVED**, the Township Clerk is authorized to forward a copy of this Resolution to the State of New Jersey Department of Community Affairs, Division of Fire Safety with all required documentation.

**BE IT FURTHER RESOLVED**, that this resolution shall take effect immediately upon passage.
