

**RESOLUTION R:251-2023**

**RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A PROPOSAL WITH FRANKLIN ALARM FOR THE INSTALLATION OF A CELLULAR DIALER AND ONE YEAR OF ALARM MONITORING PER ALARM PER TOWNSHIP BUILDING AT A TOTAL PROPOSAL PRICE OF \$8,820.00**

**WHEREAS**, the Township of Monroe, New Jersey (“Monroe Township”) identifies a vital need to bolster the security infrastructure and enhance the monitoring capability of its township buildings, ensuring the protection of township assets and the safety of its residents and personnel; and

**WHEREAS**, Franklin Alarm, with its principal place of business situated at P.O. Box 84, Franklinville, New Jersey 08322, has extended a proposal to the Township for the provisioning of a cellular dialer and a commitment of one year of alarm monitoring services per alarm per Township building; and

**WHEREAS**, said proposal has been diligently reviewed, evaluated, and deemed to satisfactorily meet the security and monitoring requirements of the Township; and

**WHEREAS**, the total financial commitment for the proposal presented by Franklin Alarm is specified to be in the amount of \$8,820.00.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe, County of Gloucester, State of Jersey, as follows:

1. The Mayor of the Township of Monroe is hereby authorized and directed to execute the proposal with Franklin Alarm for the installation of a cellular dialer and the provision of one year of alarm monitoring services per alarm per Township building at the total proposal price of \$8,820.00, as delineated in the aforementioned proposal.
2. All other terms and conditions of the proposal that have not been specifically referenced herein shall be deemed to be incorporated by reference and shall be binding upon the Township.

**BE IT FURTHER RESOLVED**, that this resolution shall take effect immediately upon passage.
