WHEREAS, Remington & Vernick Engineers estimated the improvement requires a Stormwater Management Maintenance Guarantee for the Project in the amount of \$1,071.60; and

WHEREAS, Boing US HOLDCO, Inc. DBA "Take 5 Car Wash", issued a Bond, in the form of a Cash Bond, in the amount of \$1,071.60 for the Project; and

WHEREAS, the Township of Monroe accepts the form of said Stormwater Management Maintenance Guarantee.
