RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING THE MAYOR TO SIGN AN AFFORDABILITY ASSISTANCE PROGRAM REQUEST FOR ASSISTANCE GRANT THROUGH TRIAD HOUSING PROGRAMS FOR CAMILLE PRITCHETT

WHEREAS, the Township of Monroe is committed to supporting the provision of affordable housing and has entered into an agreement with Triad Housing Programs to facilitate such support; and

WHEREAS, Camille Pritchett has applied for an affordable housing unit and intends to reside at 114 Railroad Avenue, Unit B, Williamstown, NJ 08094, with a scheduled move-in date of November 1, 2023; and

WHEREAS, the security deposit required for the aforementioned affordable housing unit is \$1,578.00; and

WHEREAS, Triad Housing Programs offers an Affordability Assistance Program Request for Assistance Grant to provide financial aid to income-qualified tenants of deed-restricted affordable apartments; and

WHEREAS, Camille Pritchett qualifies for this assistance and has requested a grant for the full amount of the security deposit.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey that:

1. The Mayor is hereby authorized to sign an Affordability Assistance Program Request for Assistance Grant application through Triad Housing Programs on behalf of Camille Pritchett for a one-time grant in the amount of \$1,578.00.
2. The Mayor and any other appropriate Township officials are also authorized to execute any and all agreements and instruments with Triad Housing Programs necessary to effectuate this grant application and to undertake all actions necessary for the administration and disbursement of grant funds in accordance with the Township's agreement with Triad Housing Programs and relevant policies
3. This resolution shall take effect immediately upon its passage, and all actions heretofore taken by Township officials with respect to this matter are hereby ratified and affirmed.
