**RESOLUTION AUTHORIZING THE EXECUTION OF A USE AGREEMENT  
BETWEEN THE TOWNSHIP OF MONROE AND THE COUNTY OF GLOUCESTER  
FOR THE 2024 NUTRITION PROJECT AT THE PFEIFFER COMMUNITY CENTER**

**WHEREAS**, the Township Council of the Township of Monroe recognizes that the County of Gloucester operates a nutrition project within the Township of Monroe; and

**WHEREAS**, the nutrition project provides nourishment for qualified individuals from Monday through Friday, for a maximum of 245 days per year, in order to accommodate a maximum of 100 people; and

**WHEREAS**, in the past, the County of Gloucester has utilized the Pfeiffer Community Center for the purposes of administering the nutrition project; and

**WHEREAS**, the parties have negotiated an agreement to further said cause in order to provide this program to the residents of the Township of Monroe; and

**WHEREAS**, the Use Agreement shall be effective from January 1, 2024 to December 31, 2024.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe that the Mayor is hereby authorized to execute said Use Agreement between the Township of Monroe and the County of Gloucester for utilization of the Pfeiffer Community Center for the Nutrition Project.
