**RESOLUTION AND NOTICE OF COUNCIL MEETINGS AND

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe, as follows:

- 1.) The Township Clerk shall post a copy of this Resolution on the bulletin board in the Municipal Building, located at 125 Virginia Avenue, Williamstown, New Jersey 08094.
- 2.) A copy of this Resolution together with all required advance written notices shall be given by the Township Clerk to the official publications of the Township of Monroe, County of Gloucester.
- 3.) The schedule of Township Council Meetings and Ordinance Committee Meetings for the year 2024 shall be in accordance with the notice annexed hereto.
- 4.) The Township Council may conduct a Closed Executive Session at any one of the above scheduled meetings without having to provide advance notice of intent to conduct a Closed Executive Session.
- 5.) The Township Council may convene a Special Council Meeting pursuant to *N.J.S.A. 10:4-18* and “adequate notice” being duly advertised.
- 6.) The Township Clerk is directed to mail all advance written notices of meetings, as defined by the Open Public Meetings Act, to all persons requesting a copy upon payment of such person for a fee as stated in the Code of the Township of Monroe to cover costs of reproduction, handling and mailing; however, newspapers shall be exempt from such fees.
- 7.) The Clerk shall be required to maintain a list of all duly scheduled meetings of all boards, commissions, authorities and such other agencies within the Township as required to comply with the provisions of the Open Public Meetings Act.
