**RESOLUTION OF THE TOWNSHIP OF MONROE, COUNTY OF GLOUCESTER,
AMENDING RESOLUTION R:278-2023 ACCEPTING AN
EMERGENCY MANAGEMENT AGENCY ASSISTANCE PROGRAM GRANT**

WHEREAS, the Township Council was requested by Resolution R:278-2023 to accept an Emergency Management Agency Assistance Program Grant; and

WHEREAS, upon further review, it was determined additional language is required in the resolution by FEMA; and

WHEREAS, upon review of the Preliminary Questionnaire submitted for the FY23 Emergency Management Performance Grant (EMPG) Program, Emergency Management Agency Assistance (EMAA), it has been determined that the Monroe Township Office of Emergency Management is eligible to submit a Subaward Application, Subaward Number FY23-EMPG-EMAA-0811, AFN #97.042 for up to \$10,000.00 of the FY2023 EMAA funding for the Performance Period of July 1, 2023 – June 30, 2024; and

WHEREAS, the completed application shall be submitted via the NJEM Grants online system; and

WHEREAS, the application will be reviewed for completeness by the County Office of Emergency Management and forwarded to the New Jersey Office of Emergency Management (NJOEM) Emergency Response Bureau; and

WHEREAS, upon completion of the Performance Period, approved Work Plan Activities, and Expenditure Certification, reimbursement will be made to the Monroe Township Office of Emergency Management by the State in the amount of \$10,000.00; and

WHEREAS, acceptance of the grant's funds is to enhance the Monroe Township Office of Emergency Management and will be used for Emergency Management purposes; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey that the Mayor, on behalf of the Monroe Township Office of Emergency Management, is hereby authorized to accept, and will accept, the Emergency Management Performance Grant and Emergency Management Assistance Program Grant in the amount of \$10,000.00.

BE IT FURTHER RESOLVED, by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey, that Resolution R:278-2023 is hereby amended with additional required language.

BE IF FURTHER RESOLVED that the subgrant, consisting of \$10,000.00 Federal Award is for the purpose of enhancing the City's ability to prevent, protect against, respond to and recover from acts of terrorism, natural disasters and other catastrophic events and emergencies.
