

**RESOLUTION R:48-2024**

**RESOLUTION AUTHORIZING THE EXECUTION OF CHANGE ORDER NO. 1 FOR THINK PAVERS HARDSCAPING IN THE DECREASED AMOUNT OF \$3,495.60 FOR SERVICES ASSOCIATED WITH THE 2022 DRAINAGE IMPROVEMENT PROJECT IN THE TOWNSHIP OF MONROE, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY**

**WHEREAS**, pursuant to Resolution R:134-2022, the Township of Monroe accepted the bid and entered into a contract with **Think Pavers Hardscaping** for services associated with the 2022 Drainage Improvement Project; and

**WHEREAS**, the engineer on the project, Pennoni Associates, has recommended Change Order No. 1 for the contract MTSPX21264, known as the 2022 Drainage Improvement Project, pursuant to their letter dated January 15, 2024; and

**WHEREAS**, the Change Order is for the final as-built quantity adjustments, fuel and asphalt price adjustments; and

**WHEREAS**, the original contract amount is **\$1,530,496.00**; and

**WHEREAS**, the Change Order is decreasing the amount of the contract by **\$3,495.60**; and

**WHEREAS**, the revisions to the prior contract and a change order is necessary in order to complete the project in the most efficient and cost-effective manner for all of the residents of the Township of Monroe.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe, County of Gloucester, and State of New Jersey that the contractor's contract is hereby amended to include a decrease in the amount of **\$3,495.60** for services and hereby approves and authorizes the execution of Change Oder No. 1 in the new amount of **\$1,527,000.40**.
