**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE
AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH
CLEAN AS A WHISTLE CLEANING SERVICE, LLC FOR
TOWNSHIP CLEANING SERVICES**

WHEREAS, the Monroe Township Municipal Building and the Monroe Township Police Department require regular professional cleaning services to maintain a hygienic and orderly environment; and

WHEREAS, the Township recognizes the need to engage a qualified cleaning service provider for these tasks and deems it in the best interest of the Township and its residents to uphold the highest standards of cleanliness and maintenance; and

WHEREAS, pursuant to Resolution R:292-2023, the Township Council authorized the issuance of a Request for Proposals (RFP) for cleaning services; and

WHEREAS, Clean As A Whistle Cleaning Service LLC responded to this RFP and was selected based on their cost-effectiveness, experience, and compliance with service requirements; and

WHEREAS, an agreement has been prepared outlining the terms and conditions for the provision of cleaning services for the period of February 1, 2024, through December 31, 2024, and ensuring compliance with all requirements as outlined in the RFP; and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe as follows:

1. The Mayor of the Township of Monroe is hereby authorized and directed to execute the agreement with **CLEAN AS A WHISTLE CLEANING SERVICE, LLC**, 705 Davinci Way, Williamstown, NJ 08094, as the selected service provider, for cleaning services as detailed in the RFP and the resultant agreement.
2. The terms and conditions of the agreement shall be in accordance with the specifications and stipulations set forth in the RFP and the Township's requirements.
3. If any part of this Resolution shall be deemed invalid, such parts shall be severed and the invalidity thereby shall not affect the remaining parts of this Resolution.
4. The CFO has certified that funds are available in the 2024 budget in line item #4-01-26-380-380-528 B&G – Contractual Services, not to exceed \$60,000.00.
5. Notice of the contract award shall be published in one of the official newspapers for the Township of Monroe.
