

**RESOLUTION R:53-2024**

**RESOLUTION AUTHORIZING THE TOWNSHIP OF MONROE  
TO ENTER INTO A CONTRACT WITH THE LABOR COUNSEL FOR

**WHEREAS**, there exists the need for the appointment of Labor Counsel for the Township of Monroe, County of Gloucester, State of New Jersey; and

**WHEREAS**, the Local Public Contracts Law N.J.S.A. 40:11-1 et seq. requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bids must be advertised; and

**WHEREAS**, this contract is awarded in accordance with the Fair and Open procedures as established in the "Pay to Play" Law N.J.S.A. 19:44A-20.5 et seq.; and

**WHEREAS**, the Township Council of the Township of Monroe in the County of Gloucester, State of New Jersey consents to the appointment of **BROWN & CONNERY, LLP** as the Labor Counsel for the Township of Monroe.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Monroe, County of Gloucester and State of New Jersey that:

1. The Mayor is authorized to sign a contract with **BROWN & CONNERY, LLP**, 360 North Haddon Avenue, Westmont, NJ 08108, on behalf of the Township of Monroe.
2. This contract period shall be from January 1, 2024 to December 31, 2024.
3. The CFO has certified that funds are available in the budget account number 4-01-20-160-160-536, entitled Legal – Labor Counsel, not to exceed \$30,000.00.
4. Notice of the contract award shall be published in one of the official newspapers for the Township of Monroe.
