**RESOLUTION OF THE TOWNSHIP OF MONROE, COUNTY OF GLOUCESTER,
STATE OF NEW JERSEY PROHIBITING LEFT TURNS AT THE PROPOSED U.S. RT.
322 DRIVEWAY FOR A WAWA LOCATED IN WILLIAMSTOWN**

WHEREAS, Glassboro Road Associates, LLC is proposing the development of a Wawa, a convenience market with gasoline together with parking, landscaped buffering, stormwater management facilities and related site improvements to be located on Block 13901, Lot 1; and

WHEREAS, the proposed facility will have a right-in/right-out only driveway on US Rt. 322, a New Jersey State Hwy. for which access permits are required by NJDOT; and

WHEREAS, NDOT requires that the Township of Monroe adopt a Resolution prohibiting left turns at the proposed US Rt. 322 driveway for the Wawa, along with other requirements set forth in an NJDOT review letter dated January 11, 2024; and

WHEREAS, in the interest of economic development along with vehicular safety, the Monroe Township Council agrees to prohibit left turns at said location.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe as follows:

1. That the Monroe Township Council hereby agrees to prohibit left turns at the proposed US Rt. 322 driveway for the Wawa, located on Block 13901, Lot 1.
2. That a copy of this resolution shall be forwarded to the developer upon adoption by the Township Council of the Township of Monroe.
