RESOLUTION AUTHORIZING THE TOWNSHIP OF MONROE TO ENTER INTO A CONTRACT WITH BAKEY ENERGY CONSULTING FOR ENERGY CONSULTANT SERVICES FOR THE TOWNSHIP OF MONROE, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY FOR THE YEAR 2024

WHEREAS, a need exists for services of an Energy Consultant in the Township of Monroe, County of Gloucester, State of New Jersey for the year 2024 to evaluate sustainable solutions while stabilizing energy costs for the Township; and

WHEREAS, the Local Public Contracts Law N.J.S.A. 40A:11 et seq. requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bids and the contract itself must be available for public inspection; and

WHEREAS, this contract is awarded in accordance with the Fair and Open procedures as established in the "Pay to Play" Law N.J.S.A. 19:44A-20.5 et seq.; and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester and State of New Jersey that:

1. The Mayor is hereby authorized to sign a contract with **BAKEY ENERGY CONSULTING**, 900 N. 9th Street, Suite 628, Philadelphia, PA 19123, on behalf of the Township of Monroe, to provide Energy Consultant Services for a period from January 24, 2024 to December 31, 2024.
2. The Chief Financial Officer has certified that sufficient funds are available in the budget account number 4-01-20-100-100-528, contingent upon the availability of sufficient funds and the adoption of the temporary or final budget for 2024.
3. A notice of this action shall be published in one of the official newspapers for the Township of Monroe as required by law.
