

**RESOLUTION R:87-2024**

**RESOLUTION AUTHORIZING THE EXECUTION OF A SHARED SERVICES AGREEMENT FOR FUEL SYSTEM USE BETWEEN THE TOWNSHIP OF MONROE AND THE MONROE TOWNSHIP BOARD OF EDUCATION**

**WHEREAS**, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., authorizes municipalities and school districts to enter into agreements to provide or receive any service within their jurisdiction, including services incidental to their primary purposes; and

**WHEREAS**, the Township of Monroe owns and operates fuel facilities capable of providing regular and diesel gasoline; and

**WHEREAS**, the Monroe Township Board of Education desires to purchase fuel from the Township for its use under the terms and conditions specified in the Shared Services Agreement; and

**WHEREAS**, the Shared Services Agreement between the Township of Monroe and the Monroe Township Board of Education for Fuel System Use, dated February 28, 2024, has been reviewed and approved by the Township Council; and

**WHEREAS**, it has been determined that entering into the Shared Services Agreement will benefit the general welfare of the citizens of the Township of Monroe and the Monroe Township School District;

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Monroe, Gloucester County, New Jersey, as follows:

1. The Mayor of the Township of Monroe is hereby authorized and directed to enter into the Shared Services Agreement with the Monroe Township Board of Education for Fuel System Use, as presented.
2. The Township Clerk is hereby directed to forward a certified copy of this resolution along with the executed Shared Services Agreement to the Monroe Township Board of Education and any additional interested bodies, and to further retain a copy in the Township's records.

**BE IT FINALLY RESOLVED** that this resolution shall take effect immediately.
