RESOLUTION AUTHORIZING THE MAYOR TO SIGN COMCAST PEG ACCESS OPERATING PROCEDURES AGREEMENT

WHEREAS, Comcast has established Operating Policies effective January 2023 for Public, Educational, and Governmental (PEG) Access Programming and related procedures; and

WHEREAS, these Operating Policies outline the requirements, responsibilities, and restrictions for becoming an Access Producer, sponsoring a program, program content standards, and the use of the Access Channel, among other provisions; and

WHEREAS, the Township of Monroe recognizes the value of Comcast's services in providing a platform for expression and free speech within the community, as well as the educational and governmental benefits of PEG Access Programming; and

WHEREAS, it is in the best interest of the Township of Monroe and its residents to engage in an agreement with Comcast to ensure the continued provision and improvement of local cable programming and services; and

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Monroe, Gloucester County, New Jersey, as follows:

1. The Mayor is hereby authorized and directed to sign the Comcast Operating Policies Agreement on behalf of the Township of Monroe, thereby adopting the terms and conditions set forth in the Comcast PEG Access Operating Procedures document.
2. This agreement will facilitate the Township's engagement with Comcast in providing PEG Access Programming and related services, in accordance with the terms outlined in the Comcast Operating Policies effective from the last date of signing.

BE IT FINALLY RESOLVED that this resolution shall take effect immediately.
