**WHEREAS**, after due deliberation and consultation, the Township Council of the Township of Monroe has determined it is in the interest of the residents of the Township of Monroe that said agreement between the Township of Monroe and John McBride, be authorized and executed by the proper Township of Monroe Officials; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe that the Mayor is hereby authorized to execute said agreement for the period of March 1, 2024 through December 31, 2025.
