**RESOLUTION AUTHORIZING THE TOWNSHIP OF MONROE

WHEREAS, there exists the need for services of a Special Counsel for Litigation in the Township of Monroe, County of Gloucester, State of New Jersey; and

WHEREAS, the Local Public Contracts Law N.J.S.A. 40:11-1 et seq. requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bids must be advertised; and

WHEREAS, this contract is awarded in accordance with the Fair and Open procedures as established in the "Pay to Play" Law N.J.S.A. 19:44A-20.5 et seq.; and

WHEREAS, the Township Council of the Township of Monroe in the County of Gloucester, State of New Jersey consents to the appointment of **BROWN & CONNERY, LLP** as the Litigation Special Counsel for the Township of Monroe.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Monroe, County of Gloucester and State of New Jersey that:

1. The Mayor is authorized to sign a contract with **BROWN & CONNERY, LLP**, 360 North Haddon Avenue, Westmont, NJ 08108, on behalf of the Township of Monroe.
2. This contract period shall be from January 1, 2024 to December 31, 2024.
3. The CFO has certified that \$30,000.00 is available in the budget account number 4-01-20-160-160-519.
4. Notice of the contract award shall be published in one of the official newspapers for the Township of Monroe.
