**RESOLUTION APPOINTING ALTERNATE FUND COMMISSIONER FOR
THE GLOUCESTER, SALEM, CUMBERLAND COUNTIES
MUNICIPAL JOINT INSURANCE FUND**

WHEREAS, the Township of Monroe has resolved to join the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund, hereinafter referred to as FUND; and

WHEREAS, each municipality that is a participant in the FUND is required to appoint a commissioner to the FUND, as well as an Alternate Commissioner; and

WHEREAS, the appointment of a JIF Fund Commissioner is necessary to attend and represent Monroe Township at the JIF meetings, to keep up to date with the rules and regulations of JIF and to vote to enact JIF policy at meetings; and

WHEREAS, an alternate JIF Fund Commissioner is required to stand in the place of the Commissioner should he/she not be able to complete any of his/her duties; and

WHEREAS, Township Council of the Township of Monroe, County of Gloucester, has determined that it is appropriate to appoint **Business Administrator, James V. DeHart, III** as the Monroe Township Alternate JIF Fund Commissioner; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey, that **Business Administrator, James V. DeHart, III** is hereby appointed Alternate JIF Fund Commissioner for the Tri-County Joint Insurance Fund.
