WHEREAS, Remington & Vernick Engineers, Township Engineer on the Project, by letter dated February 13, 2024, required a Performance Guarantee (Landscape Buffer) amount and inspection escrow for the Site known as Mews at St. Mary Senior Housing (Block 11501, Lot 1); and

WHEREAS, Remington & Vernick Engineers estimated the improvement requires a guarantee of a Performance Guarantee (Landscape Buffer) for the Project as follows:

Engineering Inspection Escrow*	\$53,739.35

WHEREAS, Diocesan Housing Services Corporation of the Diocese of Camden, Inc., Developer, issued a Performance Surety Bond in the amount of \$43,440.00 for the Project; and

WHEREAS, the Township of Monroe accepts the form of said Performance Guarantee.
